On seeing your application with self declaration and  
supervision report of the School, which was submitted by the  
Supervision committee, Recognition is granted to Florence Inter-  
national School, Fatehgarh Shukarchak Road, Verka Bye Pass Amritsar  
which is newly opened by Florance Education Society, from Class Pre-  
Primary to 8th class for March 2011.

Above recognition is given on the following terms and  
condition:-

1. Sanction of obtained recognition is not extenable,  
In any case, it will not be considered that this  
recognition is compulsory for more than upper classess  
of eight class.
2. The School will act upon the free and compulsory  
education of children Rights Act, 2009 (Annexure-I)  
and free and compulsory education of children -  
Rights Rules 2011 (Annexure-2) and its sub-rules.
3. In the first class of School (or pre-school class),  
whichever is applicable, The school will admit the  
children of total strength of the class=25% weak and  
getting non-facility of nearby areas and provide  
free and compulsory education to them and school will  
enquire till the completion of the education

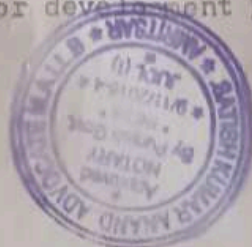


As mentioned in the Para No.3 of the School, The  
expenses will be completed according to Act and  
its section 12 of Sub-Section(2) for the children  
as provided in the Act, For getting the completion  
of expenses, the school will open seperate Bank  
account for this purposes.

5. The Institution/School will not get any competition  
fee and school will not adopt any procedure for child  
or his parents or surplus selection.



6. The School will not refuse to admit to any student in the School due to non-availability of birth proof, and school must act upon the Act and its section 15 of its provision. The School will must assure (A) that any student which is admitted, the same child will not retain in the class or child will not be eliminated from the school till the completion of his preliminary education.(B) No any punishment will be given to the child physically or mental tension.(C) It will not be compulsory to pass the examination of the Board(D).Each student will get the recognition letter according to Rule 25 who had completed the preliminary education (E).According to the provision of the Act,special needs/admission of Handicapped students.(F). It is compulsory for the teacher that they will have fulfill educational qualifications according to Sub Section 23(i) (G). The teacher will perform the responsibilities according to Teacher Act of Section 24(1) (g) The teacher will not remain individually busy in the Private Tutition.
7. On the basis of teaching subjects of the school education will be given as provided syllabus by the reasonable authority.
8. The School will abide by the prescribed the terms and conditions as mentioned in the School Act of Section 19.Facilities are given below as mentioned in the report of previous enquiry  
(A) Total area is 5452 is saure yards within the boundry of four walls of the school and there are 11 trained teachers and 01 School Head.(B) Society is constituted and its registration No is 29 for the years 2015-16. (C) T.L.M. Punjabi education Language is used in the School and black boards are built.(D) Furniture,electricity,water and air condition building are provided in the boundry of four walls of school.(E)There is a separate room for the Head of the School.(F)Total rooms of the School are 12. There are total 8 flush-laterines out of them 04 for girls and 04 for the boys (G). There is a library in the School in which 250 books are available. (H) 220 days are fixed as working days in the School.Plants/Trees are grown.There is a play ground in the School and apparatus are available. The record is completed for the Teachers (I) Building safety and Fire safety certificate exists (fitted with fire safety apparatus. The land of the school is on lease. There is no any interruption to teaching the School.
9. No any non\_recognition class will not run in the building of the School or outside of this School or not in the name of this School.
10. The building of the School of other structure or ground will only be used for the education or development purposes.

11. The School society had been registered according to Registration Act 1860 (1860 of 21) by the Registered Society which is run by the Trust under the laws implemented from time to time.
12. The School will renew the necessary documents i.e. Building safety certificate, Fire safety certificate etc. on the completion of term of expiry period. and Copy will be deposited in the office of Distt. Education Officer (E. Ed.) Amritsar. In case, if any negligence will be found in this connection then the recognition will be cancelled without assigning any notice.
13. This School is not running for the personal purpose of any body or group of persons and not benefit of any person.
14. The Account will be audited by the Chartered Accountant and statements of accounts will be prepared. Copy of each report of accounts will be sent of every year to the District Education Officer.
15. Your's school recognition code No. is R.T.E. Amritsar- 01681002. Please noted and this code must be entered during the time of correspondence with this office.
16. The School Director or Distt. Education Officer will submit the information from time to time and he will perform all the conditions of recognition of the School or remove the shortcomings in the working of the School and he will act upon the instructions issued by the Punjab Govt. or local bodies authorities.
17. The Registration of renewable of the Institution of the Institution if necessary then it will be done in time.
18. The School Administration will abide by all the terms and rules to implement in the School according to R.T.E. Act 2009. In case, it will be found in failure of rules or section of R.T.E. Act or violate the same then the recognition will be cancelled of the School.
